Ms. Barnes explained the handout and our 2015-2016 allocations. Ms. Barnes explained how at the State level they have equity in mind there are districts with a high number of English Learners which benefits large urban districts such as LA and San Diego Unified. Ms. Barnes shared that the board and superintendent continue to work with Sacramento for adequate/increased funding for schools - California is 46 <sup>th</sup> in the nation as far as per pupil funding. In the past districts were able to sell off property to cover the deficit but the school board no longer wishes to sell property and the state will no longer allow districts to sell property to cover deficit spending. We do have some good news, class size in TK-3 will be reduced to 24 to 1. Ms. Barnes explained that Bay Park budget allocations were reduced by \$26,000 (in the LCFF and Discretionary resources) which means our budget was cut about 34%.
